Form A

1.1 New Construction/Acquisition Projects Land Purchase – New Location

Faulkner State has located 15 acres of prime land that will be the site of a new campus dedicated to new and existing technology programs of the College. The land is located on a major corridor between Mobile County and the Florida State line and is highly visible from Interstate 10. (See 1.2 below)

1.2 New Construction – Technology Center – New Location

Faulkner State has recently added new programs in the technical division of the College that pertain to Workforce Development initiatives in the Baldwin County area. These include welding, construction trades, automotive and other planned programs in technical and occupational areas. The College envisions purchasing another piece of land located in a high visibility area of the county and construct a 55,000 square foot facility to house these programs and provide for the future development of workforce development training.

1.3 New Construction – Production Technology/Performing Arts Center – Fairhope Campus

Faulkner State has been selected as one of several colleges and universities in Alabama to offer programs in Movie Production Technology, an important new state supported initiative to promote movie production in Alabama. This facility would provide the classroom and laboratory space for these programs and also offer a performing arts theater that could be used by students training in production technology programs as well as the College's fine arts department.

1.4 New Construction Athletic Field House – Bay Minette Campus

Faulkner State has obtained preliminary schematics and rendering for an Athletic Field House for the College's Baseball and Softball programs. The building will include new locker rooms for each team, weight rooms, offices for the Athletic Department employees, recreational areas and viewing areas for the College's guests and supporters of the College's Athletic Program. The building will be approximately 7,500 – 8,000 square feet and will be similar in design to newer buildings located on the Bay Minette campus.

2.1 Renovation/Remodeling Projects – Renovate Tyson Technology Center – Bay Minette

The Tyson Technology Center, constructed in 1994, has experienced air quality issues related to building envelope and HVAC deficiencies. To address these problems, a comprehensive renovation project will be undertaken to replace the roof and insulation, replace the HVAC system ductwork and controls, replace storefront doors and windows, reseal the exterior of the building, provide additional drainage improvements and replace damaged interior and exterior finishes.

2.2 Renovation/Remodeling Project – Renovate Career Technology Center – Bay Minette Campus

The Career Technology Center, constructed in 1988, has experienced the same air quality issues as those noted in the Tyson Technology Center described above. A comprehensive renovation project will be undertaken to address the building envelope and HVAC deficiencies that that will include the replacement of the roof and insulation, replacement of the HVAC system, ductwork and controls, replacement of storefront doors and windows, resealing exterior of the building, providing additional drainage improvements and the replacement of damaged interior and exterior finishes.

2.3 Renovation/Remodeling Projects – Administrative Annex Building – Bay Minette Campus

Faulkner State's Administrative Annex Building, which was an office building that housed the College's student services offices, will be renovated and converted into classrooms, offices and instructional dance floors for the College's Fine Arts Department. The College wishes to expand its course offerings in Dance and will need special types of flooring for courses in ballet, jazz and other forms of dance.

3.1 Major Capital Equipment Projects – Furniture & Equipment – Technology Center – New Location

Furniture and equipment for the New Location Technology Center will be purchased.

3.2 Major Capital Equipment Projects – Furniture & Equipment – Production Technology/Performing Arts Center – Fairhope Campus

Furniture and equipment for the Production Technology/Performing Arts Center in Fairhope will be purchased.

3.3 Major Capital Equipment Projects – Furniture & Equipment – Athletic Field House

Furniture and equipment for the new Athletic Field House on the Bay Minette campus will be purchased.

3.4 Major Capital Equipment Projects – Furniture & Equipment – Annex Building Renovation

Furniture and equipment for the renovation of the Annex Building on the Bay Minette Campus will be purchased.

Form B

1.1 New Construction Classroom/Conference Center Gulf Shores Campus

Faulkner State has experienced rapid enrollment growth over the last several years and demand has increased for additional classroom and office space on all campuses but especially on the Gulf Shores campus. This facility would provide a portion of the additional space needed to meet this demand. Also, incorporated into the design of this facility would be conference type rooms that would provide space for large lecture or conference type courses or meeting spaces for academic or civic groups.

1.2 New Construction – Instructional Building – Gulf Shores Campus

Due to rapid enrollment growth at the Faulkner State Gulf Shores campus, additional classroom space is needed to meet the demand for seated classes. This facility would add additional classroom and office space for the growing enrollment in the Gulf Shores campus.

2.1 Renovation/Remodeling Projects – Hodgson Hall Renovation - Bay Minette Campus

Due to demand for on-campus living facilities by students, the College is considering renovating an older residence hall to meet the demands of students on waiting lists for on-campus living facilities.

3.1 Major Capital Equipment Projects – Furniture & Equipment – Classroom/Conference Center – Gulf Shores Campus

Furniture and equipment for the Classroom/Conference Center on the Gulf Shores campus will be purchased.

3.2 Major Capital Equipment Projects – Furniture & Equipment – Instructional Building Gulf Shores Campus

Furniture and equipment for the Instructional Building on the Gulf Shores campus will be purchased.

3.3 Major Capital Equipment Projects – Furniture & Equipment – Hodgson Hall Renovation Bay Minette Campus

Furniture and equipment for the Hodgson Hall renovation on the Bay Minette campus will be purchased.
