## Facilities Master Plan Projects Description and Justification 2017-2018

---

### **1.1 Storage Building for Facilities Operations**

This project is necessary to house and protect heavy equipment (backhoe, tractors) used by facilities maintenance.

### **1.2 Welding Training Facility**

This new construction is due to the deteriorating and limited space of the current facility that houses the Welding program. Program enrollment continues to grow as industry demands increase and more space is needed. A more modern facility and equipment is needed to meet the needs of current industry standards. This facility would also house space for Advanced Manufacturing Training.

### **1.3 Incubator**

This new construction is needed to house a small business incubator with multiple work rooms designed to facilitate a wide range of entrepreneurial startup businesses. This facility is designed to promote innovation and strengthen our position with industry as a resource for incubating new ideas in a collaborative environment.

### **4.2 Roadways (Phase II)**

The College's roadways and parking lots have cracked, buckled, and separated due to use, wear and harsh winters. This project is necessary to maintain safe conditions for pedestrians and automotive traffic. This project would also avoid more extensive and expensive remedies in the future. This Phase II project will focus on improvements to Frances Dodd Drive.

## Facilities Master Plan Projects Description and Justification 2018-2019

### **1.1 Fencing and Landscaping along Highway 31**

The area along Highway 31 should be considered the “front lawn” of the campus. This project includes a wrought iron fence with brick piers and landscaping in order to create an attractive and inviting campus for students, employees, and stakeholders. The College desires a more “collegiate” look and feel to the campus which will promote strong recruiting and community support. The Campus should be convenient and inviting to visitors from the community while at the same time promoting a vibrant campus life for its students.

### **1.2 Centralized Shipping/Receiving and Storage Building for Bookstore and Facilities Operations**

A centralized shipping/receiving area for the entire campus will utilize existing staff to monitor all shipping and receiving items, to have better control and security of items, and to limit access. All shipments will come to this warehouse, including bookstore inventory, custodial (paper goods, etc.), facilities maintenance items and parts inventory.

### **4.1 Electrical Systems Update (Phase I)**

Years of use and deterioration have caused the entire underground utility system, which consists of direct burial cable with a concentric neutral, to fall into a state of disrepair. The project to renovate and replace utilities is necessary to maintain a safe learning and work environment.

### **4.2 Roadways (Phase III)**

The College’s roadways and parking lots have cracked, buckled, and separated due to use, wear and harsh winters. This project is necessary to maintain safe conditions for pedestrians and automotive traffic. This project would also avoid more extensive and expensive remedies in the future.
